Agreement between User and www.birdsofparadisesanctuary.org

Welcome to www.birdsofparadisesanctuary.org. The www.birdsofparadisesanctuary.org website (the "Site") is comprised of various web pages operated by Birds of Paradise Sanctuary ("BOPS"). www.birdsofparadisesanctuary.org is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of www.birdsofparadisesanctuary.org constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

www.birdsofparadisesanctuary.org is a Non-Profit Site.

This website is made available to the general public to explain our mission, which is to be a voice for captive exotic birds and to promote unity within the avian community. We work to fulfill our mission by providing a safe haven for abused or unwanted exotic birds (regardless of species, age, special needs or behavior issues), re-socializing and rehoming eligible companion parrots, and providing educational resources to the avian community.

Children Under Thirteen

BOPS does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. If you are under 18, you may use www.birdsofparadisesanctuary.org only with permission of a parent or guardian.

Indemnification

You agree to indemnify, defend and hold harmless BOPS, its officers, directors, employees, agents and third parties, for any losses, costs, liabilities and expenses (including reasonable attorney's fees) relating to or arising out of your use of or inability to use the Site or services, any user postings made by you, your violation of any terms of this Agreement or your violation of any rights of a third party, or your violation of any applicable laws, rules or regulations. BOPS reserves the right, at its own cost, to assume the exclusive defense and control of any matter otherwise subject to indemnification by you, in which event you will fully cooperate with BOPS in asserting any available defenses.

Arbitration

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and BOPS agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
